

ECSIF Buy In Program



What the Buy In Program will do - East Coast Stallion Fund Buy In Program will allow you to run for a lifetime of ECSIF Money, as long as the fund exists.

Why are we adding it to the ECSIF - With the growth of the East Coast Stallion Incentive Fund we are always trying to cover all the bases for all who have been involved with the fund. Over the years we have been thinking of ways to allow offsprings of stallions, no longer able to be in the fund, to be able to participate for ECSIF incentive money. We believe this ECSIF Buy In Program will do just that.

If your situation fits the criteria of the ECSIF Buy In Program, it is simple, pay a onetime, life time fee of \$250.00 and you will be eligible for the East Coast Stallion Incentive Fund Money as long as the fund exists.

If you have an off spring of an ECSIF Stallion that is no longer in the program because of

1. Death of the Stallion
2. Is no longer producing babies
3. Stallion was sold to another owner at the time he was in the program, but the new owner opted out of the ECSIF.
4. The Stallion was in the program for 2 years or paid the equivalent, bred a minimum of 5 mares but then was gelded.

A ONE TIME OPEN ENROLLMENT FOR ALL OFFSPRING OF PAST ECSIF STALLIONS LISTED BELOW WITH ONE OF THE ABOVE CRITERIA is being offered until JUNE 1 2018 of this year.

You will have til Dec 1 of the non participating year (the Stallion was no longer in Fund) (example If a stallion does not renew for 2019 you have til Dec 1 of 2019 to enroll your offspring) - If you wait to buy in later it will be \$500 up to a full 2 year period. (example Dec 1 2020) After that he is not eligible unless we do an open enrollment for all offsprings - separate rules will apply You can not run for ECSIF Money until we receive your ECSIF BUY IN Program enrollment and payment.

If you choose to participate in the ECSIF BUY IN Program and your off springs sire is no longer in the Fund you will receive the rider money of 80% of the winnings and the additional 20% will be put back in the fund for redistribution the following year.

Please complete the attached form and return it with a copy of your horses papers and the \$250.00 fee and you will be eligible to enter all ECSIF Money Classes at participating shows.

Please thank your ECSIF offsprings Stallion owners that remain in the program to continue to keep this fund going. We appreciate them and hope that you do too!
